

ACCOMODATIONS

This year's convention will be held at the Ramada Plaza by Wyndham Regina Downtown, Regina, SK. Amenities include flat screen televisions, free wi-fi, fitness center, pool and hot tub, coffee/tea maker, 24 hr front desk, and is close to Casino Regina and the Cornwall Center.

CHILD CARE SUBSIDY

Update on Negotiations

What's next? As previously communicated, negotiations between Canadian Postmasters & Assistants Association (CPAA) and Canada Post Corporation (CPC) have come to a standstill, and we have reached an impasse. The next step is to go to final offer selection arbitration where all outstanding matters are referred to an arbitrator for a final decision.

We are currently in discussions with CPC in determining a mutually agreed upon arbitrator. If we cannot agree, the Ministry will appoint one. Both parties have a vested interest in having an agreed-to arbitrator.

Once the arbitrator has been selected, then both parties will submit their final offer packages of outstanding items, and the arbitrator will review the packages. CPAA and CPC will be given an opportunity at a hearing in front of the arbitrator, to present relevant evidence and defend their offer. The arbitrator will render a decision by selecting only one of the complete offers – without any changes or amendments.

We won't know when this will happen until we have selected the arbitrator. The Bargaining committee is continuing to meet to make sure that the arbitrator is selected as soon as possible.



Personal Days No Carryover and CLC Medical Leave

This is a reminder that Personal Days No Carryover (indeterminate employees and continuous term employees) should be used by June 30th. These days do not carry over to the next personal leave cycle. They also do not get paid out like personal hours.

For terms who have earned CLC Medical Leave over the past Personal Leave calendar, you can only carry up to 10 days in your bank. These days will carry over to the new personal leave cycle, but you won't earn any more days. If you've used all of your CLC Medical Leave, you will begin earning days again starting July 1st.



GROUP POSTMASTERS:

This is a reminder to all group postmasters to print off or ask your accountant for a copy of the T2200 tax form for your expenses for your office for the 2024 tax season. You can access the form at the following web address:



Please make sure you've filled the form out properly prior to sending to your LAS for their signature. They can't sign a form that isn't filled out properly and has your signature on it.

Supplemental Declaration Forms for Group Postmasters

Postmasters in non-Corporate owned and non-Corporate leased premises, or who operate a post office in residential premises, AND who have provided commercial or equivalent insurance may submit a claim for reimbursement. Similarly, postmasters in all non-Corporate owned and non-Corporate leased premises who are required to use a telephone line that is not provided by Canada Post, or for which the postmaster doesn't receive reimbursement from Canada Post may request a reimbursement payment for the expense of using another telephone for Canada Post business.

This form must be received by June 30, 2025. Please use a trackable mailing product, such as XpressPost or registered mail to obtain proof of mailing. You can also email the form to: cpaa_sa@canadapost.postescanada.ca

The Direction of Canada Post: Where We Have Been and Where We Are Going

In December, the Minister of Labour ordered the Canadian Industrial Relations Board (CIRB) to “Assess the likelihood of the parties reaching negotiated agreements by December 31, 2024, in the current circumstances.” The CIRB decided that an agreement could not be reached between CUPW and CPC.

CUPW was then ordered to return to work.

As part of his directive to the CIRB, the Minister of Labour has appointed an “Industrial Inquiry Commission” under section 108 of the Canada Labour Code. The Minister has appointed William Kaplan to lead this commission.

The commission will have a broad mandate. It will:

- Review the issues that prevented the Union and Employer from reaching negotiated agreements.
- Make recommendations about how to amend the collective agreements.
- Make recommendations about “any other changes” to be made.
- Make recommendations about “the structures, rights and responsibilities” of the Union and Employer in collective bargaining.


The commissioner’s report is due May 15, 2025, one week before the revised expiry date of the current Urban and RSMC collective agreements.

An HO Comms was sent to each post office regarding the Industrial Inquiry Commission (IIC), and its role in the collective bargaining dispute between Canada Post and CUPW. Prior to the second round of hearings, CPAA, along with municipalities, groups, businesses, individuals, as well as labour organizations from Canada were asked to make written submissions to the IIC. The deadline was February 14, 2025. The most recent hearing dates were February 19th and 20th. Please check our website for regular updates as the situation continues to develop.

Just For You!



Vacation Leave Scheduling

Vacation leave scheduling is rapidly approaching. The new vacation leave calendar begins April 1st, therefore scheduling and posting vacation leave is to happen prior to April 1st. The postmaster selects their first choice of one continuous period of vacation leave consisting of some or all of their vacation entitlement. The Senior Assistant, Full-time Assistants, Part-time Assistants and Continuous Terms will then choose their one continuous period of vacation leave consisting of some or all their vacation leave entitlement. The cycle begins again with the postmaster until all vacation leave entitlements are posted. Please refer to Article 23 in the Collective Agreement.
