Your Union - Working Hard to Save Jobs

At the time of this writing, we know that Canada Post has presented its transformation plan to Minister Joel Lightbound. Unfortunately, we do not know what the plan entails or what the changes will look like moving forward. Our National President Dwayne Jones has held meetings with the Minister and has testified at the OGGO (Standing Committee on Government Operations and Estimates) recently. Additional data is being submitted to the committee by our National Office to help them understand the issues at hand and how important our rural post offices are to Canadians.

In April, letters were mailed out to every MLA and the Premier in our province, asking them to support and speak to their colleagues in Ottawa to keep rural post offices open. We had hoped this would have been a strong talking point for the election. In June posters were mailed out to each of our members, and we asked that they be hung up in your community. Also in June, 590 letters were mailed to all governing bodies in Saskatchewan: RMAs, towns, villages, etc. We asked them to show support by mailing the federal government and asking them to keep rural post offices open.



Christmas Hours:

Remember to request extra hours as needed during the Christmas Peak season.

DO NOT VOLUNTEER YOUR TIME! TAKE YOUR BREAKS AND LEAVE WORK ON TIME!

Art. 20.14 – Where there is immediate operational requirement for a Part Time Assistant to work extra hours and the designated approval officer(s) is/are not available, Postmasters may authorize such extra hours to be worked. In such a situation the Postmaster must report the situation to the designated approval officer(s) at the earliest opportunity.

FAQ - Letter of Interest

We've updated our FAQ on the Letter of Interest, as it has changed due to the change in our Collective Agreement. Please refer to Art. 11.08 (b) (i-iv) – Acting Assignment in the Collective Agreement for the change in who is asked first.

Q – Who is eligible to submit a letter of interest?

A – Any member that holds a permanent position (works regularly scheduled hours) full-time, senior assistants, part-time, group postmasters.

Q – I am a Postmaster; I have a part-time assistant in my office. I want to take a full day off. Who do I ask first?

A – You must ask your part-time assistant (s) first, for all hours that you will not be in the office. If they are not available, then you must ask the continuous term(s) in your office next, before asking anyone who has submitted a letter of interest to your office. Terms without continuous service are asked if no one on the letter of interest list can take the hours.

Q – Where do I get a list of people who have submitted the letter of Interest?

A – Your LAS should distribute the names/list.

Q – I am a Postmaster; I do not have any part-timers in my office. I want to take 3 hours off on Friday afternoon. Do I have to call someone from the list of names that have submitted a letter of interest?

A – No. The letter of interest only applies when you are acting as a PM or SA for a full shift.

Q – How do I know if I qualify for an Acting Assignment?

A – Art 11.08 (a) – the PM or SA position must be a higher classification level than what you are currently in.

Q – I am a continuous term. Can I submit a letter of interest to my LAS (local area supervisor)?

A – No. You must work regularly scheduled hours.


